**YOU ARE HEREBY NOTIFIED TO APPEAR on July 7, 2021 Non Appearance Show Cause 10:30 AM to answer the allegations in this case at 16715 Clay Road Suite 4 Houston, TX 77084.**

At this hearing, you will be asked to enter your plea to this charge. If you wish to contest the charge, you will enter a plea of "not guilty," indicate whether or not you waive your right to a jury trial, and the Court will then schedule your case for trial.

You may be eligible to dispose of your case prior to this setting by paying the acceptable fine and costs online using the Court's website at <http://www.jp.hctx.net/>, or by mailing in payment of the fine and costs by cashier's check or money order payable to the Justice of the Peace. For certain offenses, you may be able to apply for a driving safety course on the Court's website. You may also visit the Court at any time prior to this setting to enter your plea of guilty or no contest and pay your fine and costs, to present proof of compliance, or to enter your plea of not guilty.

In the event you are convicted, you will be assessed a fine and court costs. If you have insufficient resources or income to immediately pay all or part of the fine and costs, you will have the opportunity to be considered for an extension of time to make full payment, a payment plan, community service in lieu of monetary payment, or waiver if community service would impose an undue hardship.

If you are unable to appear on the date and time included in this notice, you may request an alternative date and time from the Court.

**If you fail to appear for this hearing and have not disposed of your case, A WARRANT MAY BE ISSUED FOR YOUR ARREST. Additionally, the Court may refer your case to collections and/or notify the Department of Public Safety to deny the renewal of your driver's license. These actions by the Court may result in the accrual of additional costs. You may also be charged with a misdemeanor offense for your failure to appear in court as required, which will result in additional fines and costs upon conviction.**
